Consequently, the total claim value is Rs. 6,04,16,200 (calculated as 23237 * 2600) and has been determine under Regulation 25 of the IBBI (Liquidation Process) Regulations, 2016.</p> <p>Mrs. Patidar holds 33.53% of the equity shares in the corporate debtor and is considered a related party. According to the provisions of Section 31A(2), no voting rights were assigned to her due to her status as a financial creditor related to the corporate debtor.</p>
