- 1) All other creditors not falling in any of the categories earlier have been classified in the category of Others
- 2) Certain creditors have submitted their claims in FORM E through authorised representatives or have submitted their claims themselves as on LCD/ICD. However since no records of their employment is available with the CD, they are being classified under the category of Others.
- 3) The value of shares for claim filed by the shareholder has been taken as the face value of the shares i.e. INR 10 per share for the purpose of admission.
- 4) Claim received from Sahara entities ("Sahara") amounting to INR 1661 crores appeared under Form F as Other creditor as per the list of creditors on CIRP Commencement Date. The Supreme Court by its order dated 16th March 2023 had passed a judgement classifying the creditor as an unsecured operational creditors or other creditors. Further, vide the same order, the Hon'ble Supreme Court recorded that the outstanding dues to Sahara were paid by Jet and the Supreme Court did not adjudicate on the matter of whether, Sahara was entitled to the additional compensation of INR 550 Cr + 18% interest and mentioned in the order that it will be open to the appellants (Sahara) to ask for revival of these appeals and adjudication of the two issues raised by them on merits before this Court. It may be noted that the Hon'ble Bombay High Court vide its order dated 4th May 2011 had held that the appellants (Sahara) are not entitled to further payment of Rs.550 crores in terms of the Consent Award dated 12.04.2007. Accordingly, in compliance with the orders of the Hon'ble Supreme Court, Bombay High Court and the NCLT, the claim of Sahara has not been accepted in the liquidation process of the Corporate Debtor.
- 5) Claim submitted by one shareholder has been admitted in the book value of the share.
- 6) For claims submitted as of the ICD in foreign currency, the amount has been converted to INR based on the exchange rate prevailing on the LCD, using either the reference rate published by the RBI (where available) or the rate published by the relevant central bank of the currency's country of origin as per Regulation 26 of the Liquidation Regulations. - 7) For the claim of Mr. Naveen Rai, the matter is currently pending with the National Consumer Disputes Redressal Commission (NCDRC) in consumer complaint No. 101 of 2018. The claim is being treated as contingent claim and will be admitted basis the outcome in the case.
